Please note:

We have highlighted the visitation for the Rehab residents as we are trying not to interfere with therapy schedules. Visitation for all other units-1S, 2N and 2S are indicated below. Please be aware of your loved one's room and unit prior to arrival.

If the number of visitors exceeds our allowed percentage rate; we will be unable to allow any more visitors during that time frame.

Visitation is for ½ hour only. Please arrive on time. After visitation session is complete, an announcement will be made, and we ask that you return your visitor's pass at the front desk.

Short term residents

Long term residents

10:00-10:30 and 2:45-3:15- 1S, 2N, 2S SATURDAY

We are tentatively adding an additional evening session for all units from 4:30-5pm (Monday- Friday)
We are only allowed to have 20% of our current census at one time in the building. Please be mindful
of those that work if you can come earlier in the day please do so.

Visitation Procedures: MASKS MUST BE WORN AT ALL TIMES COVERING NOSE & MOUTH.

Visitors will be screened upon entry to the facility. Screening shall consist of both temperature checks and screening questions to assess for signs and symptoms or potential exposure to COVID-19:

- Documentation of visitor entry screening will be maintained and available upon the DOH's
 request for purposes of inspection and potential contact tracing. Documentation shall include
 the following:
 - (a) First and last name of the visitor
 - (b) Sign in and out after visit
 - (c) Date and time of facility entry
 - (d) Phone number
 - (e) Resident name and room number
 - (f) COVID-19 screening questions

Vaccinated visitors must provide vaccination card for first visit. If both the resident and their

- visitor(s) are fully vaccinated, and the resident and visitor (s) are alone in the resident room or designated visitation area, the resident and visitor may close contact (including touch) as long as they perform hand-hygiene before and after.
- Unvaccinated visitors must receive a covid test prior to visitation. Visitors may be tested at the
 facility during our testing time. Unvaccinated visitors may visit in main dining room or
 outdoors only.
- 3. Visitation appointments no longer need to be scheduled in advance. The hours of visitation will be on a specified schedule. (See above)
- 4. Only 2 visitors per resident at one time. If there are already 2 visitors visiting a resident, we will be unable to allow entry for additional visitors. We are only allowed 20% of resident census to visit at any one time and must limit total number of visitors in the facility at one time in order to maintain the core principles of infection prevention
- 5. Visitors should continue to physically distance from other residents, visitors, and staff in the facility.
